Mr. Parker fielded questions from the Board and recommended their approval.
19. First Read: \#9070 Acceptable Imagery for the Public Schools of Petoskey

Mr. Parker noted that this is a first read of revised Policy \#9070 Acceptable Imagery. The revision would remove the Northmen head as an approved logo for Petoskey Schools. Mr. Parker read an email, received today from Ian Record from the National Congress of American Indians (NCAI), regarding the negative effect that Native American imagery/logos/mascots has on Native American students. NCAI is the oldest, largest, and most representative national organization representing tribal nations and peoples. Our job is to lift up everybody that we serve and to elevate each student to the next level and equip them with the tools and belief that they can do what they set out to do. Mr. Parker is requesting the Board review the policy and remove the Northmen head logo as an approved image.

## Trustee Reed

- Reviewed the schools imagery in 2017 and the imagery committee was started
- The committee spoke with and listened to the community
- The committee spoke with tribal members at the tribal headquarters regarding the logo
- Would recommend that the committee reconvene to discuss and review comments


## Trustee Ashley

- Thoughtful review of stakeholders opinions


## Trustee Ling

- Agree that we should reconvene the committee
- We are listening and appreciate the comments and viewpoints of the community
- Times can change


## Trustee Shaw-Nolff

- Timely process
- Committee should meet soon


## Trustee Reed

- Use the same staff position committee members that were on the committee before


## Trustee Szajnecki

- Would like to focus on our community's concerns not the national issues


## Trustee Ling

- The logo and mascot have become very blended
- Times have changed
- We need to listen to the community

- When considering all decisions that are voted upon, our first priority should be focused on how this affects our students
- The logo must be babysat


## Trustee Reed

- We can control what goes on in the district

- Recommend that we ask Arlene Naganashe to continue as a member
- Contact tribal chair for recommendation of others

## 21. Superintendent's Report

Mr. Parker
Thank you to Trustee Shaw-Nolff for the kind words about Abe. We are working with local and national resources to help students and families heal, to provide support and to try to keep these things from happening. Posters with hotline numbers for local businesses have been distributed.

- Legislatively:
- Spoke on a Zoom call with Senator Schmidt
- What if anything will the federal government do in relation to COVID relief funds
- There was significant conversation regarding pupil count, seat time, days, hours, etc.
- Still are expecting cuts for 20/21 - we do not know the total dollar amount of the cuts
- The Return to School Roadmap was released on June 30, 2020
- Two task forces have met this week
- We sent a quick survey to parents to see if we should look into an online program
- 20-25\% surveyed would choose online
- The plans will need to be approved by the Board of Education by August 15, 2020
- Three main prongs
- In person option - following guidelines
- Full online option - folks not ready, medically fragile
- Distance learning - utilize curriculum for those that need to quarantine, if the building has to close, or if the district drops back to phases 1-3
- The online and distance learning programs will be more robust than what we had in the spring.
- Classes will be more rigorous
- Assignments, assessments, grading and participation will be an expectation
- Will resume communication on a regular basis, every Friday with staff and families, mid week if needed
- Focus on social and emotional needs of our staff and students
- Sinking fund projects continue
- Laying the carpet will not interfere with the start of school
- Permit issues for high school bathrooms at the moment but have been assured the project will be completed
- Spitler parking lot will be repaved starting tomorrow
- Concrete was poured at Sheridan for the basketball hoop
- Foster and Veurink properties were assessed today and we will have the quotes at the August meeting
- Will use a sealed bid process for the sale of the houses
- Mr. VanTreese will handle the paperwork at no cost
- Thank you to Mr. VanTreese
- Trustee Ling requested that the Board get a copy of the parent survey and results

- Teach the local native history to honor the Native Americans in our community
- Caution the Board about just asking people to be on the committee
- Honor the resolution and speak to the tribal council

Brenda Kulbieda, 1209 Hoag Road, Petoskey

- Honored by the native symbol that represents our teams
- Brings pride to her and her family, family enjoys native activities
- Does not consider the logo a mascot
- Reminds her of her grandfather, doesn't see how it is offensive
- Appreciates that the Board is putting together a committee
- Online learning - hope that kids can go back to school, isolation is awful, did take survey

Sjana Baker, 1679 M-119, Petoskey, member of Little Traverse Bay Bands, 2016 graduate

- Need more than two Native Americans on the board
- How were the natives chosen to be on the committee
- Letter from Mr. Parker stated that the school has the responsibility to show respect to all people
- Examine the use of the mascot
- It causes hurt and embarrassment to a lot of native people even though the white people are not hurt by it.
- Appreciate comments/research

Val Meyerson, 802 Baxter Street, Petoskey

- Do no harm - this is the most important thing that we need to remember
- We need to care and respect the request of the Native American's in our area

Tiffany Lenau, 444 E Mitchell Street, Petoskey

- White girl, have been in schools with native mascots her whole life, hard to cheer about Indians, always felt very conflicted
- Thank you Chris for your words tonight
- Remain trauma informed
- Reminder that tribal council didn't want the image in 2005
- Can community be on the committee, she would like to attend
- Is it ok to continue to teach racism to our students?
- Info on number of signatures on petition?

- Honor the tribe with the name of the town and school
- We have to babysit the logo when we shouldn't still be using it, it is problematic in our schools, would like it changed

- Started the petition - 1,250 signatures
