1. Call to Order and Roll Call Called to order at 7:00 PM.

2. The Pledge of Allegiance President Ling led the Pledge of Allegiance.

3. Resolution: English Embedded Honors

Moved by ASHLEY and supported by PETOSKEY to embed Honors into English I, II, III, and IV beginning with the 2022-23 school year. Mrs. Gamble and teachers from the PHS English Department (Lennon, Simon, Lesky) discussed Embedded Honors and fielded questions from the Board.

4. Audience Participation

**Melanie Meengs, Petoskey:** Discussed curriculum concerns. Concerned about lost enrichment opportunities at Elem, Middle, and High School levels. Concerned about reduction of sections of honors courses at the high school. Questioned removal of science and social studies lessons at the elementary level and said that she has talked to teachers about their concerns. Embedding honors is doing a disservice to students.

**Katie Schmidt:** Discussed an interaction with Superintendent Parker and Mrs. Ringle. Stated that Mr. Parker did not make eye contact with her and wanted to get out of his chair. Stated that

she did not get answers from Mr. Parker. Concerned about behaviors in son's class and is afraid that it is negatively impacting her son. States there is a lack of proper leadership in the school district.

**Kimberly Senior:** Wants to discuss band situation. Upset that nobody talked to students about the resignation of Mr. Ryan. Thinks administration should have talked to students and parents about Mr. Ryan's resignation before talking to the news media. The band students have had a rough two years, it would have been nice to show the students the respect they deserve.

**Trista Carver:** Has 8th grader at PMS and former graduate of PHS. Daughter reached out to administrators and said 504 meeting was started by administrator mocking my daughter. She called the counseling office and said her daughter was lost and needed help and was told that she received a tour. Another administrator called them about an attendance issue and had a very positive experience. Stated there are administrators here who do not care, are asleep at the wheel, egocentric, and only care if there is something on the table for them. Every child matters. Kids are aware of this and know they are not all treated equally. Need removal of some administrators.

**Joel Kato, Petoskey:** Band Directors could not address students because they did not know Mr. Ryan had resigned. Thanked board for engaging with Mike Washburn and was impressed with his resume. Thinks the Board is headed down the right path with this process. It will be critical to categorize the input in a timely manner and put together actionable plans. May also want to consider doing this again 12 months from now. Heard there has been a good turnout, so maybe make this an ongoing process.

**Summer Poquette, Petoskey:** Wants to acknowledge Casie Parker, who runs DECA. Recently took students to Detroit to competition in Marketing and Business. She stated she was invited into PHS to be a judge to help students prepare for these competitions. She would like to encourage the Board to grow more programs like this. Also encourages the Board to get students more work study program to gain experience and help the workforce. She stated that businesses would love to have students come work with them and it would help students gain on the job experience.

## 15. Audience Participation

**Melanie Meengs, Petoskey:** Expressed disappointment in the Board passing the embedded honors program. Students pride themselves in taking hard classes and embedded honors waters down this honors distinction. Students sitting near her were taking honors classes and did not support the Board's passing of the embedded honors program. Did not discuss students with IEPs and what teachers will have to do to juggle that. Her daughter was bored to tears in a prior class where there was a student with an IEP who needed additional support. Thinks students should have been consulted with before making the embedded honors decision. Concerned this is a disservice to the students. Hopes Board can revisit this decision before it goes too far.

**EJ Olgaski:** Happy about the change of communication will be implemented. Didn't get any followup on his concern about the "no place for hate" group. Concerned that students would have to acknowledge having a type of privilege which could include being white or a boy? Is this the state's role to discuss white privilege, or is this topic best left out of the school system?

**Kimberly Senior:** Happy to be allowed back in the schools. Did not know we didn't have full time nurses on staff. She is interested in helping put more nurses in all of our schools for a multitude of reasons. Wants us to get a microphone over by the presentation screen so that when presenters are speaking you can hear them. Thanked the Board for the update of the search policies. Assumes parents get called when a student gets called. Addressed importance of discussing race in the school system.

**Joe Murphy:** Graduated PHS in 1972. Lots of wonderful things happening in the school system. Center for Change has hired him to be their education liaison to ensure schools have adequate funding. Working with legislature to codify how students react if they are suspended or expelled and asked the Board to look into that. Suspensions and expulsions have increased since

the pandemic started.

**Trista Carver:** 8th grader PMS, former 10th grader at PHS. Nice to see so many positive changes in schools, but wants the bad apples removed from schools. Cannot make progress unless the bad apples are removed. Have to have people who care in schools. Responses are cold, feels programmed. PHS failed our daughter. School is guilty, bad apples are guilty and should be held accountable.

**Beth Flynn, Petoskey:** Mr. Parker did not make eye contact with speakers and that is disrespectful and insulting. Need somebody who is going to lead the district who is always going to strive to put people first. Teachers are tired, worn out, and deserve better. They need to feel like they're noticed and looked at. Hopes that evaluation goes somewhere and we find somebody who's going to be a champion for all of us.
