As part of our continuous Curriculum Review cycle, a proposal for the Kids Read Now program was brought to the District Teaching and Learning Committee (DTLC) on March 8 and April 12th, 2023. The purpose of the program is to mitigate learning loss over the summer and to continue to promote a love of reading. Students receive eight books over the summer that include activities connected to each book. There is an incentive provided by the school for participation.

The DTLC gave positive, constructive feedback regarding the presentation and supported the recommendations being presented to the Board of Education for approval. If approved, the resources would be immediately purchased for a one-time implementation and would begin in the summer of the 2022/2023 school year. The resolution was recommended for approval.
