OPENING STATEMENT

Yesterday, Governor Gretchen Whitmer signed Executive Order 2020-15 to order a temporary change to the Open Meetings Act to allow public bodies to conduct their meetings electronically, while also facilitating public participation, until April 15, 2020 at 11:59PM.

Under Executive Order 2020-15, public bodies that are subject to the Open Meetings Act, including boards, commissions, committees, subcommittees, authorities, councils, and nonprofit boards, can use telephoneor video-conferencing methods to continue meeting and conducting business during the coronavirus (COVID-19) public health crisis, so long as they follow certain procedures to ensure meaningful access and participation by members of the public body and the general public.

In order to maintain the level of transparency that Governor Whitmer has sought under previous executive actions taken during her first month in office, public bodies must meet the following criteria when holding a public meeting electronically:

- Ensure two-way communication for members and the public to hear and address each other.
- Provide adequate notice to the public of the meeting.
- Post a public meeting notice on their website.
- Permit participants to record or broadcast the public meeting.
- Allow participants to address the public body during a public comment period.

The order also temporarily authorizes public bodies, departments, and agencies to use technology to enable remote participation in public comment and hearings, and temporarily excuses school boards from monthly meeting requirements.

- 2. We are in a mandatory closure of schools in accordance with Governor Whitmer's Executive Order to help slow the spread of COVID-19. We will remain closed through April 6, 2020 and plan to resume classes on April 7, 2020. We are communicating updates to staff via our internal Outlook email system. They have been directed to check email daily during this closure. We are communicating to parents, guardians, and community members regarding COVID-19 via our District's website at <u>www.petoskeyschools.org</u>. That same information is also being shared via Twitter in an effort to reach the most people possible. Additionally, I will be interviewing on 9&10 and Lite 96 tomorrow morning to help share what we are doing related to school lunches and preparations over the closure, with the hope of ensuring as many families as possible can take advantage of the feeding program.
- 3. While we expect to be back to school on April 7, 2020, planning is also underway for the possibility that the closure extends past that date. We are gathering information from our Local ISD partners, MASA, MASSP, MDE, the Legislature, Office of Special Education Programs, and the Governor's office, as well as many National sources of information. A focus for us is to ensure equitable access to educational opportunity for all students if we are placed in an extended closure situation. This includes, among other variables:
 - a. Students who have and do not have access to internet and internet capable devices
 - b. Students who are in elementary, middle, and high school
 - c. Students who receive accommodations and supports through 504 and special education
- 4. At present, our teaching staff has shared some online links or reading possibilities for students over the closure, but there are NO expectations for assignment completion, quizzes, or tests. This closure equates to around 9 days, similar to what we missed last year due to snow days. Our teachers are highly skilled and we are confident that they have the experience and skill to overcome these lost days and get students where they need to be by the end of the year if we are not closed any additional days.

- 5. The legislature passed an emergency supplemental appropriations bill late Tuesday night. They did not pass a school aid supplemental and they did not address providing relief to school districts regarding hours / days requirements due to this mandated shut down. We will continue to encourage this flexibility from our legislators in the coming days and weeks, as well as needed flexibility in other areas of the school code during this unusual time.
- 6. The legislature is scheduled to be on break for the next four weeks with one "emergency" day scheduled for each week. After that they plan to meet three days per week until the FY 21 budget is complete.
