The Public Schools of Petoskey is accepting student applications for non resident students pursuant to Section 105 of the State Aid Act, subject to availability.

Parents/Guardians may identify building preferences however, assignments will be based on class sizes.

There is no tuition charge for students accepted under the schools of choice program.

Transportation of students accepted under schools of choice will be the responsibility of the parent/guardian.

If more students apply than there are available seats, preference will first be given to siblings of students currently enrolled and then other applicants randomly selected.

Once a student is accepted, they may continue for the balance of their K-12 education if there is no break in enrollment including expulsion. If a student leaves and wishes to return, they will have to re-apply.

2. The completed application (signed by your resident school district designee) must be received by June 14th, 2024.
